The following is a summary of the proceedings of the Special Council Meeting held on October 10, 2023:

- Council participated in an Emergency Management Workshop conducted by Fire Chief, Jack Burt.

The following is a summary of the proceedings of the Council Meeting held on October 10, 2023:

- Council approved the minutes of the Council Meeting from September 25, 2023.
- Council approved the transfer of Rescue 17 to the Public Works Department.
- Council approved the removal of the Holding “H” Zone at 67 Almack Beach Laneway.
- Council approved the negotiation and registration of a No Demand for Services Site Plan Control Agreement for 67 Almack Beach Laneway.
- Council accepted the proposal from Ball Constructions Ltd. To provide Pre-construction and Construction Management Services for the Lion’s Head Community Centre Redevelopment Project in the amount of \$1,121,220.00 + HST.
- Council received a report from the Clerk regarding a Ontario Provincial Police Detachment Board Proposal Update.
- Council approved the cancellation of the January 22, 2024, Council meeting due to the Rural Ontario Municipal Association (ROMA) Conference.
- Council received a report from the Chief Administrative Officer regarding the Northern Bruce Peninsula Fire Service Review.
  - It was noted that a Special Council meeting will be scheduled at a later date to discuss Fire Services.
- Council approved the minutes of the Cemetery Committee Meeting from October 4, 2023.
- Council received the approved Accounts Payable Voucher for September 2023, in the amount of \$4,433,700.22.

- Mayor McIver inquired regarding an update on the resurfacing of the Lion's Head Tennis Court.
  - Parks and Facilities Manager, Mark Coleman, noted that the agreement with the Bluewater District Schoolboard has expired. He further noted that a new draft agreement has been requested by the Municipality.
- Council received several correspondence items as information.
- Council supported a request from Waterloo MPP, Catherine Fife regarding support for Bill 2, Fixing Long-term Care Amendment Act (Till Death Do Us Part), 2022.
- Council noted and filed a Resolution from the County of Brant regarding Guaranteed Livable Income.
- Council supported the Ministry of Municipal Affairs and Housing, Housing Task Force Recommendations selected by staff.
- Council approved four by-laws: A Deeming By-law, a By-law to removal the Holding (H) Zone from 100 Old Woman's River Road, a By-law to remove the Holding (H) Zone from 67 Almack Beach Laneway, and a Confirmatory By-law.
