



Municipality of Northern Bruce Peninsula Council Meeting Highlights June 12, 2023

The following is a summary of the proceedings of the Council Meeting held on June 12, 2023:

- Council approved the minutes of the Regular Council Meeting on May 23, 2023.
- Council received a delegation from William Streeter regarding the John Pearson plaque rededication.
- Council received a delegation from Traci Smith of BDO regarding the Audit Final Report.
- Council received a report from the GIS/IT Manager regarding the Municipal Website Update.
 - It was noted that the Municipal Website will be down for a brief period on Thursday, June 15, 2023, to facilitate the activation of the new website.
- Council received a report from the Parks and Facilities Manager regarding a progress report for the Lion's Head Arena Project.
- Council supported a report from the Parks and Facilities Manager regarding The Meeting Place – Ontario Trillium Foundation Capital Grant Application.
- Council approved the passing of By-law 2023-54 which authorizes the Mayor and Clerk to execute the renewal of DataFix Voter List Management Services Agreement for the 2026 Municipal Election.
- Council received a report from the Chief Administrative Officer regarding a Municipal Drainage Committee.
 - Council approved the Terms of Reference for the Municipal Drainage Committee
- Council received a report from the Chief Administrative Officer regarding development charges as information.
- Council received a report from the Chief Administrative Officer regarding Council Remuneration.
- Council received a report from the Chief Administrative Officer regarding the Northern Bruce Peninsula Community Improvement Plan.
 - It was noted that there is a Public Meeting regarding the Community Improvement Plan at 1:00 p.m. on June 26, 2023.

- Council approved the May 2, 2023, minutes of the Ad Hoc Museum Committee.
- Council approved the May 24, 2023, and June 7, 2023, minutes of the Chi Cheemaun Festival Committee.
- Council approved the May 2023 Accounts Payable Voucher in the amount of \$705,104.04
- Discussion ensued regarding the expansion of the Municipal Accommodation Tax Program.
 - It was noted that the expansion of the Municipal Accommodation Tax Program will become effective on January 1, 2024.
- Deputy Mayor Anderson inquired regarding the status of the Tobermory Pickleball/Tennis Court.
 - Parks and Facilities Manager, Mark Coleman, noted that a tender has been awarded regarding the installation of a new surface for the court.
 - It was noted that repairs to the Lion's Head Pickleball/ Tennis Court are experiencing delays.
- Deputy Mayor Anderson stated that additional communication methods should be utilized concerning the total fire ban within the Municipality.
- Councillor Golden inquired regarding the importance of contacting Parks Canada and submitting an additional request for a meeting concerning the National Marine Conservation Areas.
- Council received several items of correspondence as information.
- Council proclaimed June 15, 2023, World Elder Abuse Awareness Day
- Council supported a letter of support from Lanark County.
- Council proclaimed June 15, 2023, as World Elder Abuse Awareness Day
- Council supported a resolution from Lanark County regarding legislative measures
- Council approved three by-laws: A by-law to authorize an agreement with Golden Dawn Seniors Home for the Provision of Shuttle Services, A by-law to enter into an agreement with Comprint Systems Inc doing business as DataFix for the 2023 Municipal Election, and a Confirmatory By-law
