

Municipality of Northern Bruce Peninsula Council Meeting Highlights September 11, 2023

The following is a summary of the proceedings of the Council Meeting held on September 11, 2023:

- Council approved the minutes of Special Council Meeting and amended minutes of the Regular Council Meeting from August 28, 2023.
- A Public Meeting was held regarding Zoning By-law Amendment Z-2023-061 (Charette c/o Ron Davidson).
- Council received a delegation from the Bruce County Director of Corporate Services regarding a Bruce County Development Charge Presentation.
- Council received a delegation from the Friends of Cabot Head regarding the Cabot Head Lighthouse Update.
- Council authorized a extension of the Winter Maintenance Agreement with Bruce County for another five-year term, concluding on April 30, 2028.
- Council approved a Trailer Agreement for 18 Constance Drive.
- Council approved a Trailer Agreement for 146 Walter Charman Drive.
- Council approved a Trailer Agreement for 30 Huron Street.
- Council received a report from the Chief Administrative Officer regarding Cabot Head Road.
- Council approved the minutes of the August 1, 2023, meeting of the Museum Committee.
- Council received the approved Accounts Payable Voucher for August 2023 in the amount of \$1,604,311.42.
- Council received several correspondence items as information.
- Council directed the Public Works Department to contact the Lindsay Road 20 Ratepayers Association regarding the installation of "No Exit" and "Wildlife Crossing" signs.
- Council supported the requests of Bob Miller regarding the Tobermory Trail Race Weekend.
- Council approved five by-laws: A By-Law to Assume and Declare a Parcel of Land in the Municipality of Northern Bruce Peninsula as a Public Highway Part of

Lot 23 Concession 3 WBR being on Registered Plan 3M-257 - 11 Lots - Trillium Crossing- Phase 3, a By-Law to Assume and Declare a Parcel of Land in the Municipality of Northern Bruce Peninsula as a Public Highway Part of Lots 23 and 24 Concession 4 WBR on Registered Plan 3M-263 and Blocks 13 and 14 being on Registered Plan 3M-257 Trillium Crossing Road - Phase 4, a By-Law to Adopt a Memorial Bench and Tree Policy, a By-Law to Authorize a Lease Agreement Between Mary Robbins and the Municipality, and a Confirmatory By-law
