BY-LAW NO. 2018-22

BEING A BY-LAW TO SET FEES AND CHARGES FOR THE MUNICIPALITY OF
NORTHERN BRUCE PENINSULA

WHEREAS Section 391 of the Municipal Act, 2001, as amended, authorizes a municipality to pass by-laws imposing fees or charges on any class of persons,

- a) for services or activities provided or done by or on behalf of it;
- b) for costs payable by it for services or activities provided or done by or on behalf of any other municipal or local board; and
- c) for the use of its property including property under its control


AND WHEREAS Section 398 of the aforesaid Act allows a municipality to add fees and charges imposed to the tax roll for the property in the local municipality and collect them in the same manner as municipal taxes.


NOW THEREFORE the Municipal Council of the Corporation of the Municipality of Northern Bruce Peninsula enacts as follows:

1. THAT a listing of fees and charges be developed for and be adopted by the Municipality of Northern Bruce Peninsula and this listing be attached hereto as Schedule A to this by-law.
2. THAT, should any fee or charge authorized by this by-law remain unpaid and past due, staff is hereby authorized to add any such outstanding receivable together with any applicable interest to the tax roll for the property of the owners which are responsible for paying the outstanding fee or charge.
3. THAT it is intended that all provisions of the by-law shall be binding and effective. In the event that any particular provision(s) or part of a provision is found to be void, violable, or unenforceable for any reason whatsoever, then the particular provision(s) or part of the provision shall be deemed severed from the remainder of this by-law and all other provisions shall remain in full force.
4. THAT this by-law supersedes any by-law or fee in any other by-law not consistent with this by-law.
5. THAT this by-law shall be known as the "Fees and Charges By-law".
6. THAT this by-law shall come into full force and effect upon passing.
