



Municipality of Northern Bruce Peninsula Council Meeting Highlights November 14, 2023

The following is a summary of the proceedings of the Council Meeting held on November 14, 2023:

- Council approved the minutes of the Council Meeting from October 23, 2023.
- A Public Meeting was held for Zoning By-law Amendment Z-2023-076 (Sharma).
 - Council approved Zoning By-law Amendment Z-2023-076 and the necessary by-law will be forwarded to Council for adoption at a subsequent Council Meeting.
- Council received a delegation from the Bruce Peninsula Health Foundation and Brightshores Health System regarding a request for funding.
- Council received a delegation from Wes Rydall regarding the Lion's Head Arena Project.
- Council awarded an agreement for the provision of cellular devices and services to Rogers Communications Inc. commencing on December 1, 2023, for a period of 3 years.
- Council awarded the contract for Supply, Installation, and Support of Cloud Hosted Telephony System to Infinity Network Solutions Inc. in the amount of \$10,4000 (excluding HST) for implementation plus the cost of hardware and regular servicing fees.
- Council received a report from the Public Works Manager regarding the 2023/2024 Winter Control Handbook.
- Council received a report from the Fire Chief regarding the Community Emergency Preparedness Grant.
 - Council supported the grant application for a Remotely Piloted Aircraft System (RPAS) program.
- Council received a report from the Chief Building Official regarding a By-law to provide for Licensing, Regulating, and Governing Food Truck Businesses.
 - It was noted that the report will be placed on NBP Let's Talk for Public Comment until November 27, 2023.
 - It was further noted that a subsequent report will be brought back to Council on December 11, 2023.

- Council approved the proposed 2024 Budget Timetable.
- Council directed staff to proceed to a Public Meeting to receive comments regarding the draft Procedural By-law.
- Council directed staff to submit to the County of Bruce Planning and Economic Development Department, the Municipality's comments to a severance of 25 Simpson Avenue to create a 7-lot subdivision.
- Council supported holding a Public Meeting on Monday, November 27, 2023, at 1:00 p.m. with respect to the proposed amendments to the Municipality's Fees and Charges By-law.
- Council received approved Accounts Payable Voucher for October 2023, in the amount of \$1,637,131.06.
- Deputy Mayor, Rod Anderson, commented regarding an exercise involving the Lindsay Tract Fire Emergency Scenario held by Fire Chief, Jack Burt, on November 2, 2023.
 - It was noted that the scenario demonstrated a comprehensive overview of a potential forest fire emergency and the associated responses within the Municipality.
- Mayor McIver noted that he attended the grand opening of the Tobermory Daycare.
 - He further noted that the new facility demonstrates a key component of the community.
- The Council meeting scheduled for Monday, December 18, 2023, was cancelled.
- Council received several correspondence items as information.
- Council supported a resolution from the Municipality of West-Grey regarding Childcare availability in Ontario.
- Council supported a resolution from the Town of Rainy River regarding Water Treatment Training Opportunities.
- Council supported a resolution from the Township of Clearview regarding Municipal Codes of Conduct.
- Council supported a resolution from the Town of Huntsville regarding Floating Accommodations.
- Council supported a resolution from the Town of Parry Sound regarding Automated Speed Enforcement systems.
- Council directed a correspondence item to the Public Works Department regarding Cape Hurd area speed reduction requests.
- Council directed the Parks and Facilities Manager to work with the Lion's Head Friendship Club in keeping them abreast of the Arena upgrades.
- Council approved a Confirmatory By-law.
- Following Closed Session, Mayor McIver advised that Council approved the minutes of September 11, 2023, Closed Session meeting and the CAO provided a verbal update with regards to 360-Degree Performance Review for a Municipal staff member.
