



## Municipality of Northern Bruce Peninsula Council Meeting Highlights April 22, 2024

The following is a summary of the proceedings of the Regular Council Meeting held on April 22, 2024:

- Council approved the minutes of the Regular Council Meeting held on April 8, 2024.
- Council received a delegation from Shared Tower regarding the proposed Telecommunication Tower at 75 Lindsay Road 40.
- Council received a delegation from Mark Prieur regarding a Pickleball Tournament.
  - Council approved the waiving of the fees for the rental of the Lion's Head Arena on June 1 and 2, 2024, for a Pickleball Tournament.
  - The request to have the parking fees waived was denied.
- Council approved a Partial No Demand for Services Site Plan Control Agreement for 237 Rush Cove Road.
- Council deferred a report from the Chief Building Official surrounding the proposed cell tower at 75 Lindsay Road 40.
  - It was noted that the report will be on the agenda for the May 13, 2024, Council Meeting.
- Council executed a Software Licence Agreement between ParkPass Inc and the Municipality of Northern Bruce Peninsula.
- Council approved two Tile Loan Applications pending funding from OMAFRA.
- Council received a report from the Treasurer regarding an Audit Planning Letter.
- Council directed staff to submit the Municipality's comments to the Niagara Escarpment Commission (NEC), regarding the Development Permit application for Part Lots 49 and 50, Concession 2 EBR, Former St. Edmunds, Municipality of Northern Bruce Peninsula.
- Council received a report from the Clerk regarding the Community Member Appointment for the Grey Bruce Detachment Board.
- Council directed staff to submit the Municipality's position of no objection to a severance submitted for 193 Tamarac Road.

- Council approved the renewal agreement with the Golden Dawn Seniors Home for the operation of a shuttle service within Lion's Head from June 28, 2024, to September 2, 2024.
- Council approved the September 13, 2023, minutes of the Physician Recruitment and Retention Committee.
- Council directed staff to prepare a report surrounding a request to investigate alternatives for streetlights within the Municipality.
- Council received several pieces of correspondence as information.
- Council directed staff to include areas in Tobermory on the agenda for the April 26, 2024, Special Council Meeting Re: Road Tour with respect to correspondence items #12 and #13.
