



Municipality of Northern Bruce Peninsula Council Meeting Highlights June 26, 2023

The following is a summary of the proceedings of the Council Meeting held on June 26, 2023:

- Council approved the minutes of the Regular Council Meeting on June 12, 2023.
- A public meeting was held regarding the Community Improvement Plan.
- Council received a delegation from Regional Tourism Organization Stakeholder Relations Manager, Kim Clarke, regarding Environics Data Presentation on Tourism.
- Council received a delegation from Shift Solar Inc. regarding a request for Municipal Support for a 20MW solar + storage system at the intersection of Highway 6 and Little Pike Bay Road.
 - A report will be brought to Council by the Chief Administrative Officer with more information on the proposed project prior to Council supporting the request.
- Council received a report from the Committee and Licensing Coordinator regarding a by-law for the amendments to the Short-term Accommodation By-law previously approved by Council.
- Council received a report from the Public Works Manager regarding the 2022 Structure Inspection Report.
- Council authorized staff to proceed with the purchase of a 2024 Freightliner FL114SD for \$380,375, plus HST.
- Council received a report from the Public Works Manager regarding the Hayes Drive Storm Sewer.
- Council approved a Trailer Agreement for 29 Walter Charman Drive.
- Council approved a No Demand for Services Site Plan Control Agreement for 12 Green Cedar Drive.
- Council approved the removal of the Holding "H" Zone for 12 Green Cedar Drive.
- Council accepted the proposal from ABC Recreation Ltd. for the design, supply, and installation of new playground and swings equipment at the Tobermory School Bell Park and Lion's Head Beach Park in the amount of \$138,947.73 + HST.

- Council received a report from the Municipal Law Enforcement Officer regarding 2023 Bylaw Enforcement Officer Appointments.
- Council directed staff to submit “no comments” to the Niagara Escarpment Commission (NEC) regarding the Development Permit application for the property known as Part Lot 13, Concession 12 EBR, Municipality of Northern Bruce Peninsula (Eastnor), County of Bruce.
- Council authorized the Mayor and Clerk to execute an amendment to the Agreement for Integrity Commissioner Services between the Municipality of Northern Bruce Peninsula and Aird and Berlis LLP, contract to continue to December 31, 2026.
- Council deferred a report from the Clerk regarding the Municipal Accommodation Tax- Clarification for Enforcement Date of By-law 2023-51.
- Council approved the Council Meeting Schedule for 2024.
- Council received a report from the Clerk regarding Fees and Charges By-law No. 2023-59 – Proposed Amendments and/or Additions.
 - A Public Meeting will be held on Monday, July 10, 2023, at 1:00 p.m. at the Municipal Office (56 Lindsay Road 5) and online via Zoom.
- Councillor Golden inquired pertaining to the responsibility of Bruce County to maintain the fixtures within the Tobermory Ambulance Base. She further stated that replacing the toilets to ensure that the current models do not run constantly throughout the day would assist in the water issues currently facing the surrounding facilities, including the Tobermory Ambulance Base.
 - Mayor McIver noted that staff will investigate this inquiry.
- Council received several items of correspondence as information.
- Council supported a resolution from The Women of Ontario Say No regarding legislative amendments to improve Municipal Codes of Conduct and Enforcement.
- Council supported a resolution from the Municipality of West Grey regarding Bell-Hydro Infrastructure.
- Council supported the Pike Bay Community Association’s application for a capital grant from the Community Foundation Grey-Bruce.
- Council approved four by-laws: A by-law to restrict the weight of vehicles passing over Municipal Bridges, a By-law to adopt an Asset Retirement Obligations Policy, a By-law to lift the Holding “H” Zone for 12 Green Cedar Drive, and a Confirmatory By-law
- Following Closed Session, Mayor McIver advised that Council approved the previous minutes of May 23, 2023, the CAO presented an on an overview and a personnel matter and Council provided direction to the CAO.
