The Municipality reserves the right to select any number of areas to be performed by a private contractor.

## **Sidewalk Blower and Sander**

Tobermory Sidewalks and Parking Lots: please see attached for detailed locations.

Plow and sander routes may be adjusted as required by the Municipality with no change in standby rates. All routes shall correspond with the Municipality of Northern Bruce Peninsula's Winter Control Handbook for the current year, as amended from time to time. A copy of the Winter Control Handbook can be viewed online at [www.northbrucepeninsula.ca](http://www.northbrucepeninsula.ca).

## **Supply and Maintenance of Equipment**

1. The equipment owners are responsible for all parts and repairs on the equipment supplied by the contractor.
2. The contractor will be required to house and station their truck at a location within 15 kilometres of the closest road within the beat tendered.
3. All repairs are to be carried out as soon as possible.
4. The contractor supplying equipment must have a valid Commercial Vehicle Operator's Registration (CVOR) for the duration of the contract. A copy of the CVOR and ownership must be submitted within 14 calendar days of the awarding of the contract.
5. Equipment inspections, certifications, pollutions standards, etc. in accordance with the Ontario Ministry of Transportation (MTO) requirements, will be required and will be considered as a non-payable component.
6. The Municipality may install radios and GPS fleet management equipment each fall at no cost to the contractor and may choose to have it removed each spring.

## **Hours of Work**

1. The truck and operators shall be available for work 24 hours per day, seven days a week, commencing December 1 and concluding March 31 of the following year. This may be deferred at the discretion of the Municipality. The contractor must have sufficient staff available to operate continuously, if necessary.
2. Hours of Work Restrictions – The regulations made under the Highway Traffic Act, Ontario Regulation 555/06, Hours of Service, as amended from time to time, will apply to the operation of the equipment used for routine maintenance operations.
3. The contractor shall submit, in writing, the names, addresses, telephone numbers, Driver's Licence numbers and Class of Licence for all operators to the Municipality no later than December 1 for each year of the contract. The contractor will be responsible for training their staff. Failure to provide a list of operators will result in the loss of standby and possible termination of contract.
4. The operator(s) of the contractor's truck(s) must be available by telephone and the truck operators located as to be able to proceed operations within 30 minutes of being telephoned. An answering service will be allowed, provided a paging system is utilized.
5. No other operators shall be used unless the Municipality is notified at least five days in advance of the names, addresses, telephone numbers, Driver's Licence numbers and Class of Licence of the persons to be added to the list.
6. Time to be counted as working hours commences when the plow starts plowing and continues until operations are completed. All discrepancies with hours worked will be determined by and at the final discretion of the Municipality's GPS program.

7. The Municipality cannot guarantee any minimum hours of work for the contractor. All plowing hours are strictly weather related. The contractor will commence work according to the Municipality of Northern Bruce Peninsula's Winter Control Handbook.

## **Liability Statement**

### **Indemnification**

The contractor shall indemnify the Municipality, its officers, employees and agents from all claims, demands, actions or other proceedings initiated by others arising out of or attributable to anything done or omitted to be done by the contractor, its officers, employees or agents in connection with the services performed or required to be performed under this contract.

### **Insurance**

As per By-law 2025-70, Purchasing Policy, the contractor shall furnish the Municipality, at their cost, with a copy of a liability insurance policy covering public liability and property damage for no less than \$2,500,000.00 (general liability and automobile liability policies) and shall remain in effect for the entire contract period. The policy must contain:

- A "Cross Liability" clause or endorsement;
- An endorsement certifying that the Corporation of the Municipality of Northern Bruce Peninsula and the successful bidder are included as an additional name insureds; and
- An endorsement to the effect that the policy or policies will not be altered, cancelled or allowed to lapse without 30 days prior written notice to the Municipality of Northern Bruce Peninsula.

Contractor's Liability Insurance Policy shall not contain any exclusion of liability for damage, etc. to property, building or land.

The contractor shall provide proof of insurance (Certificate of Insurance or Certified copy of Policy) to the Municipality before December 1 for each of the three years under the duration of the contract.

## **General Information**

### **Protection of Work and Property**

The contractor shall be held responsible by the Municipality for all damage caused by themselves, their employees, or any subcontractors, including but not limited to damage to

vehicles, subsurface utilities, properties, pavement, sidewalks, curbs, buildings, homes or structures adjacent to or in the general area of the work, through any other cause relating to the work carried out under the contract. Additionally, the contractor will be required to make good all such damage at their own expense to the satisfaction of both the owner and the Municipality.

The contractor shall be fully responsible for all accidents arising by reason of execution or non-execution, or non-repairs of the said works, or by reason of any failure to comply with the requirements of this clause and shall fully indemnify the Municipality in respect thereof.

### **Wages**

The contractor shall be responsible for payment of the wages of any operator hired, and when required, shall furnish evidence to the satisfaction of the Municipality that these wages have been paid in full. If the contractor fails to do so, the Municipality shall have the right to withhold payment for such sums of money due that would be sufficient to cover the default. The contractor's employees are not employees of the Municipality under any circumstances whatsoever.

### **Fuel Escalation/De-Escalation**

The Municipality recognizes the volatility of the fuel market and provides for an adjustment (increase or decrease) to the hourly rate paid based upon the Petro Canada rack fuel price of Ultra Low Sulphur (ULS) Diesel – Toronto, ON. This posted rack price is based upon the average weekly rack fuel price (the average of daily rack pricing from Saturday to Friday, effective the next Saturday). The fuel escalation/de-escalation rate is to be applied on each invoice based on the corresponding weekly rack price. Bidders are asked to submit pricing based upon Petro Canada weekly rack fuel price of \$1.0556 per litre on July 19, 2025.

For each change, plus or minus \$0.05 in the rack price, the hourly tendered price will be adjusted plus or minus \$1.00.

In the case of fuel prices per litre increasing/reducing further than shown on the above chart, per hour rate would increase/decrease at the same ratio.

### **Standby**

The designated sum shall not be paid if the equipment is not available to start work as required and will be paid for every day that the equipment is under contract and available. Standby shall be paid from the start of the winter season, December 1, until it is dismissed at the end of the winter control season, at a minimum on March 31.

### **Workers' Compensation Act**

The Municipality does not cover the contractor or their employees under the *Workers' Compensation Act*. The contractor is responsible for paying all dues and assessments payable under the *Workers' Compensation Act*, the *Unemployment Insurance Act* or any other act, whether Provincial or Federal, for themselves and employees for all winter operations. The contractor shall, upon request, furnish the Municipality with satisfactory evidence that they have complied with the provisions of such acts. If the contractor fails to do so, the Municipality shall have the right to withhold payment of such sum or sums of money due to him/her that would be sufficient to cover their defaults and the Municipality shall have the right to pay the same. Information on coverage under *the Workers' Compensation Act* can be obtained directly from the Workers' Compensation Board.

### **Option to Inspect**

The contractor may inspect, with the Patrol Supervisor, in advance of any plowing operations, all roadways within their designated area of plowing, noting the location of protruding man holes, catch basins, culvert ends, curbing ends, utility installations, mailboxes, signs, guide rails, bridges, homes/buildings close to the pavement and hazardous locations. The contractor must ensure that no damage is caused to such installations, plant, equipment, homes or other facilities during plowing operations. If, in the opinion of the Patrol Supervisor, unreasonable or preventable damage results to

Municipal or private property as a result of the contractor's plowing operations, then the contractor shall be responsible and shall reimburse the Municipality or landowner the cost of repairing the damage.

### **Failure to Perform Work**

If the contractor fails to perform the work or fails to perform it to the satisfaction of the Municipality, or fails to comply with any of the conditions specified in this contract, they shall be liable for any loss or damage suffered by the Municipality as a result of their default and the Municipality may deduct the amount of its damages from any monies due or to become due to them from any source whatsoever.

### **Winter Control Handbook**

The contractor shall perform work in coordination with the Municipality of Northern Bruce Peninsula's Winter Control Handbook, as amended from time to time.

### **Safety**

1. The contractor must comply with the *Occupational Health and Safety Act & Regulations, R.S.O. 1990*, and will be responsible for the compliance therewith of any of their drivers or employees while working on this contract.
2. The contractor will supply and ensure that all operators use protective clothing and/or devices as set out in the *Ontario Occupational Health and Safety Act & Regulations, R.S.O. 1990*.
3. The minimum age of the operators will be 18.

### **Liquidated Damages**

1. It is agreed by the parties of this contract, in addition to the third-party liabilities set out above, that in case the plow with necessary personnel is not available to proceed with plowing when required by the Patrol Supervisor or their designate, or if available, the contractor's operator refuses or delays in proceeding with the plowing as directed by the Patrol Supervisor, damages will be sustained by the Municipality.
2. Since it will be impracticable to ascertain and determine the actual damage which the Municipality will sustain in the event of, and by reason of such delay or such failure of the equipment or personnel to be ready, the parties agree that the contractor will be required to pay the Municipality liquidated damages in the following amounts:
  - a. \$150.00 for the first hour or fraction thereof after 30 minutes notification has been given by the Patrol Supervisor. This charge will continue until:
    - i. The contractor's plow commences work; or
    - ii. The Patrol Supervisor has ordered snowplowing operations to cease.
  - b. \$100.00 per hour for every hour or fraction thereof after the initial hour of not being able to continue operations due to a failure of the contractor's equipment. This charge will continue until:

- i. The contractor's plow commences work; or
  - ii. The Patrol Supervisor has ordered snowplowing operations to cease.
3. Notwithstanding the above, in the case of the truck being broken down or otherwise unavailable, the loss of standby time payment shall be enforced.

## **Specifications**

The trucks and snowplow equipment shall meet the following specifications:

### **Trucks**

- The truck inspection sticker must bear an inspection date of September 1 or later for each year of the contract.
- Trucks shall have a minimum manufacturer's front axle rating of 18,000 lbs. The contractor shall supply the Municipality with proof of front axle rating (a setback front axle is acceptable).
- Trucks shall have a minimum alternator output of 110 amps.
- Trucks shall be equipped with traction type dual rear tires.
- Trucks shall be equipped with all equipment, accessories and licences required by the *Ontario Highway Traffic Act* and any other acts, regulations or by-laws that apply to truck operation.
- Trucks shall meet the Ontario Ministry of Transportation's specifications for lighting requirements.
- Trucks must be equipped with an alcohol evaporator for the air brake system or an air drier.
- Trucks must be equipped with braking on all axles.
- The speedometer, odometer and the hour meter shall be working accurately.
- Trucks shall have tandem front mounted hydraulic pumps capable of operating the plow, wing and sander simultaneously; minimum 30 gpm.
- Trucks shall have fender tripod mounted 8" convex mirrors, on both left and right fenders.
- Trucks shall have a front wing post convex mirror (8" or 12") on wing post.
- Trucks shall have an in-cab fan for clearing the windows.
- Truck cab mirrors shall be the heated type.
- Regulation Snowplow lights

### **Snowplow Equipment**

- Trucks shall be equipped with a full hydraulic tower, a front frame mount, 12 foot one-way snowplow (a Frink model 450 SK.8, Viking model 135 HSE9 or approved equal). The wing shall be 12 feet long (a Frink model 311-12R, Viking model 144-WH-D or approved equal).

- The operations of all snowplow equipment must be controlled from within the cab and the controls must be convenient to the driver.
- A revolving blue light on the cab or wing tower and the yellow flashing light on the back frame shall be supplied and mounted by the contractor.
- Wings must be equipped with a tripping device and one-way plows equipped with hydraulic roll.
- Sander unit must meet the Municipality's approval and have a carrying capacity of 10 cubic yards or more.

### **Sidewalk Equipment**

- Sidewalk winter maintenance equipment must be suitable to provide snow and slush removal, along with sanding/salting functions. Winter maintenance activities must be completed behind hydro poles and other narrow areas that may require handwork.
- Handwork is required for, but may not be limited, to the Tobermory Clinic, Library and downtown.

### **Tractor and Blower**

- Parking lot and street winter maintenance equipment must be a minimum of 7-foot blower and a minimum of 85 horsepower and have the capabilities for salting and sanding.
